The Chair informed the committee that at last nights Senate meeting, the office of the Vice-President, Research and International (VPRI) presented their new Strategic Research Plan (SRP). The Chair encouraged committee members to be involved in ongoing consultations.

Topic discussed included the new admission platform goGrad, and funding data for graduate research programs. 5.1.2 Program Change: Indigenous Business Leadership Graduate Certificate Program Change: Indigenous Business Leadership Graduate Diploma Program Change: Indigenous Business Leadership EMBA

A. Gemino informed the committee that Beedie has partnered with universities across Canada and a number of Indigenous communities across British Columbia to create an 'on the land' experience. Once a term, an Indigenous community will host business classes on their land to engage in discussions regarding Indigenous economics and reconciliation. This program is the first of its kind and hosts students from across Canada, in addition to those from Beedie. The goal of the program is to create a national program that uses 'on the land' experiences to bring students and Indigenous leaders together to discuss various topics surrounding reconciliation.

K. Gerlich-Fitzgerald clarified that the items under 5.1.2 required minor editorial changes. A. Gemino received the edits prior to the meeting and approved the amendments. Changes include removing redundant language in the calendar entries (SGSC13, SGSC15) and additional language added around limits on special topics courses (SGSC14, SGSC16).

A committee member asked for clarification on the rationale for having courses with 0 units. K. Gerlich-Fitzgerald explained that Satisfactory/Unsatisfactory (S/U) graded courses do not count towards program requirements. Since the department has listed the courses within their program requirements, making them 0 units will ensure they do not affect the University minimum required program unit total. The Chair added that 0 credit courses are becoming increasingly more commonplace as programs put more value on courses designed for cohort building and professional development.

5.4 Graduate General Regulation 1.5 Graduate Grading Systems and Policies

Implementing the proposed GGR change would encourage students to discuss their course selection and grading options with their supervisor at the beginning of term. K. Gerlich-Fitzgerald explained that the policy was in response to the many cases where students ask to change a course to a Satisfactory/Unsatisfactory (S/U) grading basis after a course has been graded. Retroactive changes to enrollment status may have financial implications, therefore, changes being made within the first 2 weeks limit those impacts.

R. Muntean raised concerns with the language used in the policy, explaining that it would deter students from seeking changes if extenuating cases arose during the term. One committee member highlighted that withdrawing from the course or withdrawing under extenuating circumstance would still be available. The Chair proposed an amendment to the policy by removing the line "retroactive changes will not be considered", as the sentence

prior explains that changes must be made by end of week two.

6. For Discussion

6.1 Guaranteed Minimum Funding

The Chair stated that the move towards minimums reflects the university's commitment towards providing a living wage for staff, faculty, and students. The committee discussed options for financing guaranteed minimum funding. Several committee members offered examples of how they distribute funds within their department. L. McCandless explained that in the Faculty of Health Sciences, half of their funding is from research grants, while the other half is used from faculty resources (TAships, RAships, GFs, etc.) In many cases, if faculty members have funds available, they will fully fund a student which allows faculty resources to be redistributed.

It was agreed that this topic would be revisited in further SGSC discussions.

6.2 1.5.2 SU Courses Towards Program Requirements

The item was reintroduced to the committee about the desire to change the GGRs to allow Satisfactory/Unsatisfactory (S/U) courses to be used within program requirements within certain limits. She reiterated that this change would be optional for programs to implement at their discretion. A committee member clarified that this discussion was framed around courses designated S/U and not on students who have elected to change the grading basis to S/U courses.

The largest concern for S/U courses was that it would lead to an artificial inflation of CGPA. The Chair explained that scholarships have been increasingly leaning away from evaluating students based solely on their GPAs. However, the issue of grade inflation should still be considered. Agnes added that it was critical to have oversight in the rubric on how S/U courses will be graded and include additional criteria for competency-based grades. It was agreed that this topic will be revisited in further SGSC discussions.
