

## Tier 2 Canada Research Chair in Social Innovation and Entrepreneurship

The Beedie School of Business at Simon Fraser University (SFU) seeks outstanding candidates for a Tier 2 Canada Research Chair in Social Innovation and Entrepreneurship. This position includes two components: a continuing tenure-track/tenured appointment at the rank of an Assistant or Associate Professor and a nomination for a Tier 2 Canada Research Chair. We anticipate the tenure-track appointment starting in August 2021 and the Tier 2 Canada Research Chair appointment start date will be subject to the nomination process being successfully concluded. A major goal of this position is to attract a scholar to work collaboratively with RADIUS, SFU's nationally-recognized social innovation hub. Located on the unceded Coast Salish Territory - the traditional territories of the Squamish (Sḵw̱x̱wú7mesh Úxwumixw), Musqueam (x̱ʷməθkʷəy̱əm), Tsleil-Waututh, Katzie, and Kwikwetlem peoples, SFU is actively building an increasingly diverse and inclusive community.

### Qualifications

The successful candidate will undertake high-quality engaged research and have demonstrated potential for teaching excellence at the undergraduate and/or graduate levels in social innovation and/or social entrepreneurship, with an emphasis on topics that align with the goals and activities of RADIUS. Additionally, they will demonstrate justice, equity, diversity, and inclusion as foundational elements of their work and lives. Engagement with practice is an asset.

A Ph.D. or equivalent degree in social innovation, social entrepreneurship, or a related field/discipline is required by SFU. Candidates working in all areas of social innovation and/or social entrepreneurship, including but not limited to business, economics, sociology, history, policy, design, and technology are encouraged to apply.

SFU will nominate the hired faculty for a Tier 2 Canada Research Chair. This position is not contingent upon the candidate receiving a Tier 2 Canada Research Chair (CRC). However, alignment with the CRC nomination criteria will be part of the overall selection process.

If the candidate's Tier 2 CRC application is successful, the CRC is tenable for five years. The CRC appointment can be renewed once and is subject to the Chairholder demonstrating that they have achieved their objectives from their first term. Candidates are encouraged to review the initial appointment and chair renewal details of the [CRC Program](#). Tier 2 Chairs are intended for exceptional emerging scholars (i.e., candidate must have been an active researcher in their field for fewer than 10 years at the time of nomination). Candidates who are more than 10 years from their highest degree (and where career breaks exist, maternity or parental leave, extended sick leave, clinical training, and family care) may have their eligibility for a Tier 2 CRC assessed through the program's Tier 2 justification process; please see the [CRC website for eligibility details](#) or contact SFU [Institutional Strategic Awards](#).

## Duties

The successful candidate joins Beedie's Innovation & Entrepreneurship Area. They will teach courses related to social innovation and/or social entrepreneurship and contribute to the school's collaborative academic community through service. They will also be expected to work collaboratively with RADIUS. Overall, they are expected to make significant contributions to research, teaching, graduate student supervision, and knowledge mobilization across the scholarly community, professional groups, the general public, and society.

A complete application must include:

- cover letter
- an up-to-date, full curriculum vitae (include details of research and teaching, scholarly record, funding, and list of collaborations/partnerships)
- statement outlining the alignment of your research and teaching with social innovation and/or social entrepreneurship, and the work of RADIUS
- two examples of scholarly work
- proposed program of research (include an outline of the proposed CRC research program over five years, an explanation of how the proposed research aligns with SFU's Strategic Research plan, RADIUS, and advances social innovation and/or entrepreneurship research (2-6 pages single spaced))
- teaching evaluations and/or evidence of teaching potential
- statement outlining your commitment to impact; justice, equity, diversity and inclusion; engagement with practice; fit with SFU Beedie's [vision and values](#)

- names and email addresses of 4-5 referees (ranked in order of preference). SFU will contact referees directly.

SFU recognizes that alternative career paths and/or career interruptions (e.g. parental leave, leave due to illness) can impact research achievements and commits to ensuring that leaves are taken into careful consideration. Candidates are encouraged to highlight how alternative paths and/or interruptions have impacted them in their application. SFU also recognizes the value of mentoring and research training, outreach, professional service, and nontraditional areas of research and/or research outputs; demonstrated experience in increasing diversity in the previous institutional environment, and in curriculum, is also an asset.

Simon Fraser University encourages applications from all qualified applicants, however, Canadian citizens and permanent residents will be given priority.
